# **Privacy Policy**

Protecting your private information is our priority. This Statement of Privacy applies to http://www.IronHeartTech.com and IronHeart Technologies and governs data collection and usage. # **Collection of your Personal Information**

In order to better provide you with products and services offered on our Site, IronHeart may collect personally identifiable information, such as your:

#### **Use of Cookies**
